# MINUTES OF A PARISH COUNCIL MEETING HELD AT ST MARY'S CHURCH, CARLETON FOREHOE ON FRIDAY 18 MAY 2012 AT 7PM

The following members were present:- Colin House, Joy Smiley, Val Evans and Jane Fraser. The Clerk and 3 members of the public were also in attendance.

# 1. ELECTION OF CHAIRMAN

Colin House was elected as Chairman for the ensuing year, proposed by Jane Fraser, seconded by Val Evans, all in favour.

# **Public Comments:**

A member of the public asked whether there had been any progress with speed monitoring in Kimberley. The Clerk confirmed that the speed camera van had found a suitable site and would be deployed there. It was suggested that speed camera signs could be an additional deterrent. It was highlighted that vehicles turning left onto the track at Kimberley were at risk of drivers shunting them, due to an assumption that they were turning onto Wymondham Road. It was suggested that a concealed entrance sign, or a double left turn sign, could be put up. A bid could be put together ready for funding for alternate coloured asphalt or painted speed limit signs. A member of the public asked whether there was any update on the drainage on the track. It was confirmed that this had not been progressed. The member of the public highlighted that in the recent rain storms there had been run-off from the B1145 and surface water on the track.
